Pay


Participants will be paid \$108.00 per completed visit (up to \$1,512.00 total if all study visits are completed)

CDAI Tips from our Study Coordinators

As part of efforts in protecting primary endpoints, Dr Brook's site coordinators, Renee Henry & Missy Randolph, share their tips for helping manage the CDAI components.

- *eDiary compliance is heavily discussed at all screening visits. We emphasize eDiary completion and study medication compliance as being two of the most vital parts to participating in the study. We explain how completing the eDiary is important because it not only lets us know how the patient is feeling and responding/not responding to the study medication, but also how it can help us identify if the subject is starting to have a Crohn's flare. If the subject misses their diary, we contact them asap to instruct them to do their eDiary and to re-educate on completing the eDiary daily. If we have a study subject that we notice is forgetting often, we contact them every evening to remind them to complete their eDiary until it becomes a habit for them.*
- *During the study visit, the Sub-IP reviews the 6 categories (arthritis, fissure, fever, etc) and checks for abdominal mass. We ask if they have taken any Lomotil, etc and check their body weight.*
- *The CDAI cannot be completed until the hematocrit comes back, so we make a reminder to enter the hematocrit in as soon as we receive the lab report and transmit the data.*



Updating Active PIs and Coordinators in EPIC:

Researchers can make personnel changes to their study in Epic via the Research Study Maintenance Activity. It is important to ensure that study personnel remain current in Epic. Automated alerts such as Appointment Change/Update Alerts or ADT Alerts are sent to those listed on the study record in Epic. If personnel is not current in Epic, researchers not listed on the study will miss these important automated alerts. Please reference the [Research Study Maintenance Dashboard Job Aid](#) for details on how to update study staff.

In addition, Epic Research Alerts (In Basket Messages or Pager Alerts) are occasionally built to send notifications to individuals. If staff is changing on a study, it is important that the study team confirm with the outgoing staff member what automated alerts they were receiving. Epic IS&T will need to be notified to update the alert recipient.

EpicCare Link Remote Monitoring Verification Reminder for Site Administrators:

This reminder applies to those of you that serve as a Site Administrator for EpicCare Link use by external monitors. Please note, EpicCare Link requires Site Verification to be performed by Research Site Administrators in the months of **February, May, August** and **November**. The Site Verification begins on the 1st of the month and ends on the 28th of the month at which time a report is automatically generated of the sites that have not completed Site Verification and sent to the Epic Security Team for accounts to be blocked. It is required that Research Site Administrators complete this practice by logging into link.ucealth.com to verify. Failure to complete Site Verification could result in the loss of access to EpicCare Link for external users and both EpicCare Link and Epic Hyperspace for Research Site Administrators.
